

 - **Biological** → The process of BOD reduction using activated sludge, anaerobic vs. aerobic.
 - Chemical treatments → Understanding coagulants and flocculants, filter aids etc.
- ✓ Solid and liquid waste management costs and how to reduce them.
- ✓ Carbon reduction initiatives → Emerging trends towards carbon neutral industry.
